

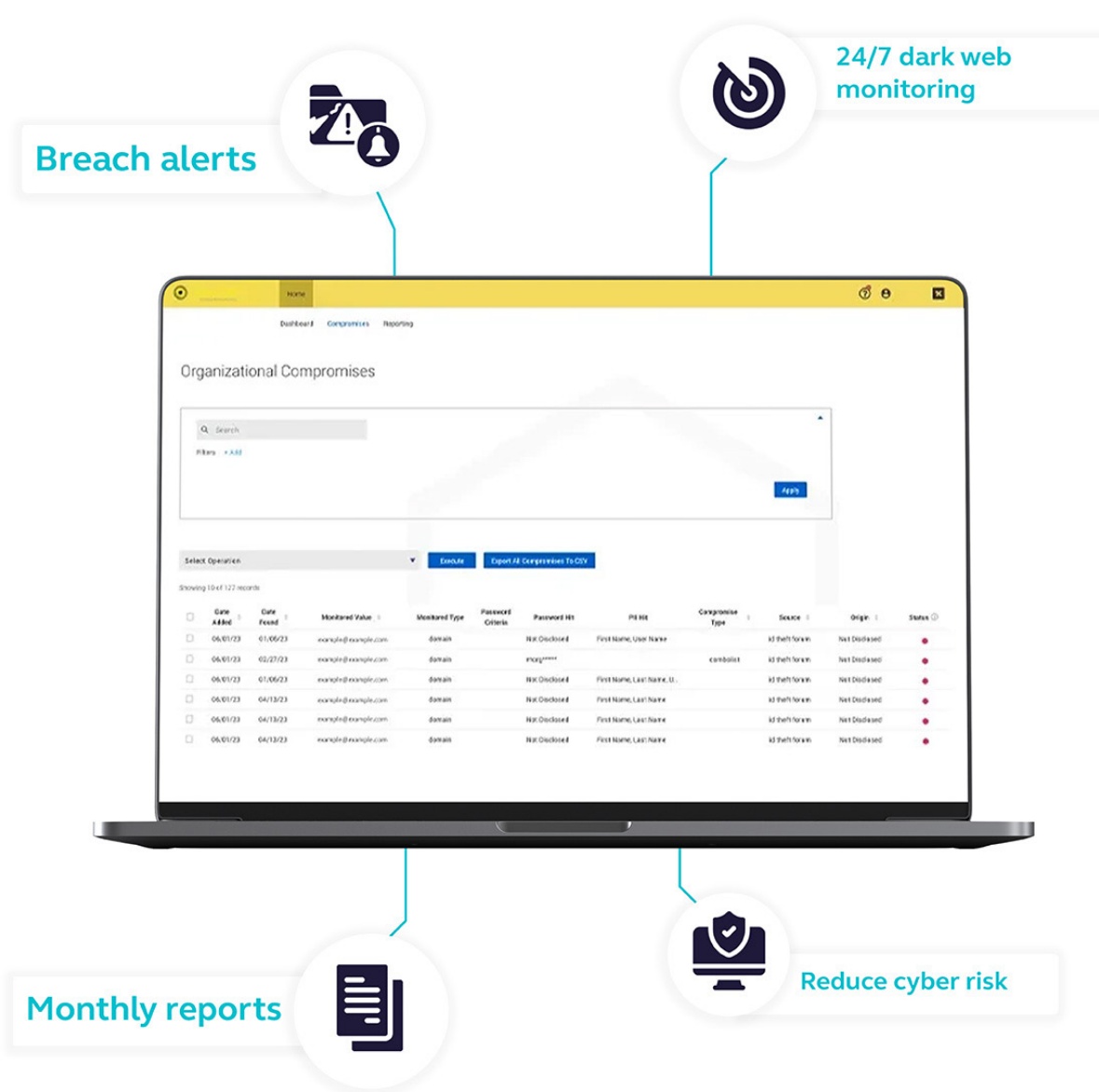

Credential theft: the new frontline of cybercrime

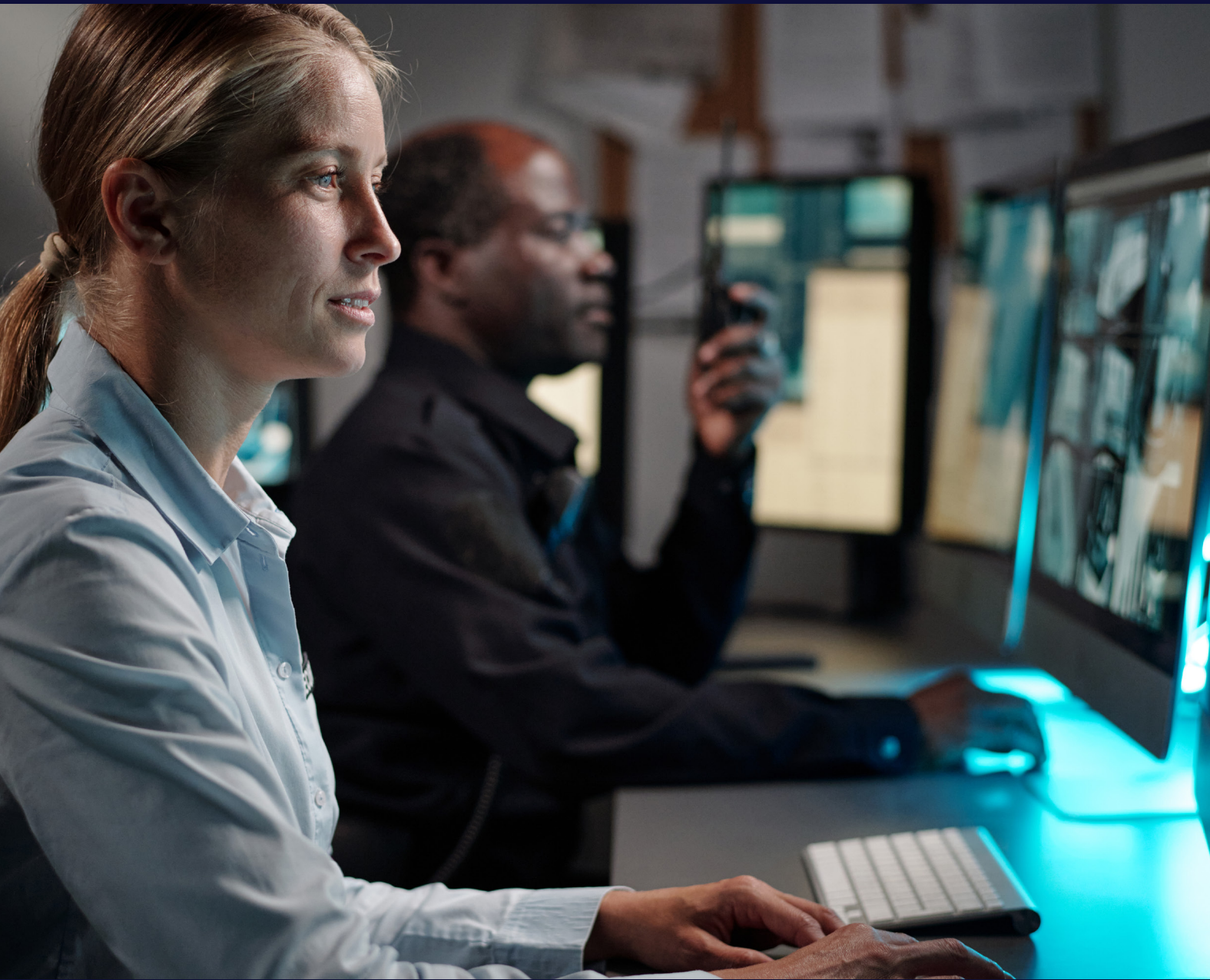
